Foster Care/Adoption Application

1. Adopter understands and agrees that the equine identified in this contract remains the property of the Rescue for a one-year period beginning on the signed date. The equine will be maintained and cared for by Adopter under this agreement and that if, in the opinion of the Rescue, Adopter has maintained and cared for the equine in a manner as set forth in the Adoption Policy's "Required Level of Care," Adopter will be allowed to retain the equine and all right, title and interest to the equine will be released to Adopter after the end of this one-year period.
2. Adopter understands that during this one-year period, Adopter may not sell, give away, lend, lease, sell for slaughter, remove from Adopter's personal supervision and control or move the equine from the address described herein, except for emergencies, shows, trail rides and other situations, without the written approval of the Rescue. During the one-year period except for reasons listed in (1), should the equine not be at the location as stated herein upon inspection by a Rescue representative, Adopter will immediately relinquish any rights or interest Adopter may have in the equine and Adopter shall assist in every way possible to locate and return said equine to the Rescue. Adopter will be responsible for any costs incurred by the Rescue to acquire and transport said equine back to the Rescue facilities. **Adopter also agrees that if the rules of this contract are not followed and horse is released to anyone other than the Rescue or Rescue approved person, adopter will be responsible for a value of horse/horses of \$2,500.00 each to be paid to the Rescue.**
3. Should Adopter decide that the equine is no longer wanted for any reason during the one-year period that equine must be returned to Rescue and no one else.
4. Adopter agrees that, during this one-year period, should it become necessary to euthanize said equine for medical reasons Adopter must provide written proof as a statement from the attending veterinarian. If horse should be found dead then veterinarian must be called to document the death before haul off can occur.
5. Adopter agrees that Rescue representative can come and inspect horse at any time to be sure that all agreements of this contract are being followed. If you are boarding this equine at a boarding facility Rescue must have access to viewing horse at any time during business hours. If you wish to move to a new location approval must be given by Rescue and new location must be filed with Rescue.
6. Adopter agrees never to breed the above-described equine for the duration of the equine's life.

7. If Adopter's death occurs during the one-year contract period, each and all parts of this contract will be transferred and automatically assigned to Adopter's heirs in their entirety as if such parties had signed the original contract.
8. Adopter represents that they have read and agree with all statements and agree to be bound by all conditions contained herein and signed by Adopter.
9. I understand that it is my responsibility to read, understand and obey the current adoption policies of the Rescue.

Adopters must be 21 years or older and have a steady source of income, the adopter is considered the person responsible for the financial support of the horse

Required level of care:

The level of care of Adoption Horses should be the highest standards in the Industry.

The horse must have all the annual shots, spring and fall.

Shots are to include Strangles, EPM, West Nile, Eastern/Western, Tetanus, Rhino, and Influenza, unless otherwise noted by your Veterinarian.

The horse must be de-wormed by paste every 3 months rotating between types, unless otherwise noted by your vet.

The horse must have daily turnout of no less than 1 hour unless there is dangerous weather. Or follow the policy of boarding facility.

A Vet is to be called for any illness and any serious injury. If diagnosis of injury or illness cannot be treated due to financial reasons, horse must be returned to Footprints 4 Life immediately.

The horse must be trimmed or shod by a qualified Farrier, going no longer than every 8 weeks. The Feet are to be cleaned regularly.

Each horse must receive the required daily feed allowance of good quality grass or Hay.

Each horse must have access to fresh water each day, all day either in buckets or in regularly cleaned out water troughs. If automatic waterer is used they must be checked daily. A stagnant pond or creek is not an acceptable primary source of water.

Adoption Horses are to have their teeth checked and floated, if needed, annually.

The adopter agrees not to work the horse beyond its physical limitations at any time or to put the horse in harm's way at any time.

Miniature Horses should not hold more than 50 pounds of body weight.

If pastured the horse must have at least one acre of clear-cut pasture with some shades per horse.

The horse must have at least a 3-sided shed in the paddock to block wind and bad weather. Preference is given to anyone that has an individual stall for each horse.

Your Pasture must have acceptable fencing.

Variations in facility requirements depend on the horse, the region and the predominant weather.

The Adopter agrees to notify Footprints 4 Life Rescue if you intend to sell or transfer the horse after the one-year period.

The Adopter agrees to contact Footprints 4 Life Rescue for the following reasons:

1) Prior to the horse being moved to another residence.

2) If Adopted Horse Dies.

3) If Adopted Horse becomes seriously injured or ill.

It is advised that the adopter pay for a Vet Check if you have any questions prior to the horse departing Footprints 4 Life Rescue Facility. All costs upon departing and while away are to be paid by the Adopter, even return transportation. Footprints 4 Life Rescue is not responsible for any accidents or injuries either to the horse or adopter after leaving our facility.

The Adopted Horse can be returned to Footprints 4 Life Rescue at any time, regardless of reason, if you can no longer provide a loving, forever home.

*** Disclosure and Release:** *Adopter represents, warrants, and declares that Adopter is aware of the following in connection with his/her adoption of the Adopted Animal from Footprints 4 Life Rescue:*

- A) That animals are different from human beings in their responses to human actions.*
- B) That the actions of animals are often unpredictable*
- C) That animals should be closely and carefully supervised when they are with or around children;*
- D) That the Adopted Animal's behavior may change after it leaves Footprints 4 Life premises.*
- E) That animals in a new environment may act differently and Adopter will afford the adopted animal adequate time (at least 7 days) to acclimate to its new environment before being ridden, to the extent the Adopted Animal is rideable;*
- F) That any statements made by Footprints 4 Life regarding the adopted animal, either orally or within this adoption agreement, are merely opinions and are made or given solely as a courtesy to those considering adopting an animal, and in no way amount to claims, representations or warranties as to the temperament, health, or mental disposition of the Adopted Animal or the suitability or safety of the Adopted Animal for Adopter's intended purposes.*
- G) Adopter releases, discharges, indemnifies and holds harmless Footprints 4 Life Rescue from and against any and all claims, liens, damages, losses, and causes of action which may be asserted by Adopter and all third parties for injury or damage to all persons, property, or thing whatsoever caused directly or indirectly by the Adopted Animal.*

Footprints 4 Life Rescue holds the right to recover the horse/s if ever abused, abandoned, neglected, starved, or mistreated, etc., in anyway. The adopter agrees to abide by the Required Level of Care, or the horse can and will be recovered by Footprints 4 Life Rescue at any time. I have read and understand the conditions of the Adoption Contract and agree to uphold the highest level of care for my Adopted Horse.

I will call FP4L HQ immediately so that FP4L can recover the horse if the adopter is late on payments to anyone for horse related bills, is abusing or neglecting the horse or planning to move the horse to another facility as that is not authorized without FP4L's written consent. I understand the adoption horse requires hay, fresh water, turn out, exercise, daily personal attention, a clean stall and fresh bedding daily, shots bi-annually, farrier and deworming every 8 weeks and dental floats annually.
